Dear Mr McGlaughlin,

I must start by saying how grateful I am for the work that Suicide Prevention Australia does in bringing awareness to the issues of suicide and its prevention in the community. I should mention I was a financial member of SPA for some time.

Over the past few years now I have become increasingly concerned about SPA's association with the Salvation Army. I understand the Salvation Army is committed to suicide prevention, as per its web site¹, and this is great.

As you are aware, especially following the release of the SPA Position Statement "Suicide and self-harm among Gay, Lesbian, Bisexual and Transgender Communities"², same-sex attracted youth are over-represented in suicide statistics. I am sure this is one of the major focuses of your organisation.

However, you may not be aware that the Salvation Army promotes an attitude of intolerance of homosexuality and bisexuality, as outlined in its Positional Statements³. I refer you to the statement on Human Sexuality, section C "Homosexuality". I have attached a copy of this document for your reference.

In particular, it states:

Homosexual practice, however, is, in the light of Scripture, clearly unacceptable⁴. Such activity is chosen behaviour and is thus a matter of the will. It is therefore able to be directed or restrained in the same way heterosexual urges are controlled. Homosexual practice would render any person ineligible for full membership (soldiership) in the Army.

4 Romans 1:26-27 Also highlights bi-sexual practice as unacceptable.

This statement would not be supported by researchers in the area of suicide prevention, sexual orientation or anyone that takes suicide prevention seriously. My concern is that for as long as the Salvation Army is attempting to prevent suicide, whilst it does not offer unqualified acceptance of homosexuality and bisexuality, it cannot be taken seriously about its full commitment to suicide prevention.

The Salvation Army offer a broad range of suicide prevention and bereavement services. 24hour telephone counselling is available on the Salvo Care Line (1300 36 36 22) and face-toface counselling is also offered. Bereaved by Suicide support groups are offered in Sydney and the Gold Coast for those who have lost a relative or friend through suicide. Hope for Life is an online information and training program designed to help concerned people respond to those at risk of suicide, and to those who have been bereaved by suicide. The Salvation Army website also offers a resources and information section which includes definitions, statistics, risk factors and warning signs.

You also have on your Facebook page a link⁵ to the Salvation Army posted in July this year:
