"The JCCV takes great pride in congratulating Mount Scopus Memorial College on its Jubilee celebrations. The establishment of a communal Jewish Day School by the Victorian Jewish Board of Deputies in 1949 was undoubtedly one of the most important decisions undertaken by the communal roof body. In recognition of the importance of the historic debates of the VJBD plenum during the course of 1948, a re-enactment event will be jointly sponsored by the JCCV and Mount Scopus as part of the Jubilee celebrations.

Over the past fifty years, Mount Scopus has served the community with distinction and has done credit to the vision and charter of the founding generation. Indeed, the success of Mount Scopus College has paved the way for the establishment of numerous other day schools the majority of which are

affiliates with the JCCV. Having regard to new realities in our community, many aspects of the constitutional relationship between the JCCV and Mount Scopus have become anachronistic and impractical. It is therefore proposed that during this, the fiftieth year since the establishment of Mount Scopus, the following measures be adopted:

- The constitutional relationship between Mount Scopus Memorial College and the JCCV will be severed and full constitutional authority for the conduct of its affairs will be devolved to the College.
- II. Mount Scopus Memorial College will become affiliated to the JCCV and will assume full membership rights in accordance with its standing as a communal organisation
- III. Both Mount Scopus Memorial College and the JCCV will, in their respective charters and activities, seek to highlight the important historical relationship that has linked them over the years.
